- 8. Launch ramp/trailer storage customers shall abide by the rules and regulations of the HTMA. Any violation of rules will result in the revoking of privileges without pro-ration of fees paid.
- 9. Launching will be at user's own risk. HTMA accepts no risk or responsibility for damage to boats, cars, trailers, personal property or personal injury that may occur while on HTMA property.
- 10. The fish cleaning station is for the exclusive use of HTMA slip owners.
- 11. Identification decal is to be displayed on the passenger side of the trailer tongue. Permit is only good for the season term specified above. Trailer storage lots must be vacated by October 15, 2022
